Collection of Information:

- Sugmya, its officials and employees are required to collect certain information (which may include sensitive personal information) from you to assist us in our relationship with you.
- You understand that during the course of using this website you may be providing Sugmya and its affiliates, vendors or partner NBFCs, such information about myself that may constitute as "sensitive personal information" as defined by the Information technology Act, 2000 and the Information Technology Act (Reasonable Security Practices and Procedures and Sensitive Personal Data or Information), Rules, 2011, and you hereby provide your consent for use of such sensitive personal information in such manner as has been provided in the Privacy Policy, by the Company, its affiliates, vendors or partner NBFC's.

 - Business Turnover
 - Business Profit After Tax
 - Existing EMI Obligation
 - ITR filed or not for the current year
 - ITR filed or not for the last year
 - Social Data from Facebook, LinkedIn, Google
 - Banking Data collected/Bank passbook
 - Balance Sheet for last 2 years (if applicable)
 - Profit & Loss statements for last 2 years (if applicable)
 - Income Tax Returns for the last 2 years
 - ID proofs (Passport, PAN, Election / Voter ID card, Driving License, Aadhaar Card, Government ID Card)
 - Address Proofs (Passport, PAN, Election / Voter ID card, Driving License, Aadhaar Card, Government ID Card, Lease Agreement, Property Tax Receipts, Electricity Bills).
 - IP address, a unique identifier for your computer, cellular phones, tablets or such other device ("Devices")
 - Information which relates to your financial affairs, business, employment, income or assets.
 - Address of place where your documents may be collected.
 - Information collected and/or disclosed at the time of personal discussions (PD) with our credit team/underwriters or documents collection employees.
 - Information which would help Sugmya determine your eligibility to avail the products and services offered.
 - Information which helps Sugmya process applications made by you for particular products and services such as bank statement, Bank passbook, income tax returns, loan co-applicant's personal information (if applicable).
 - Any personal information you may provide to us during any telephonic conversation or email communication with our employees or during document collection by our employees.
 - Any other information that Sugmya is required to collect.



2. Non-personal information

- At this Website, information sent by your web browser, may be automatically collected. This information typically includes the domain name (the site after the @ in your e-mail address). It may also contain your user's name (the name before the @ in your e-mail address). Other examples of information collected by our server include the Internet Protocol (IP) address used to connect the visitor's computer to the Internet, operating system and platform, the average time spent on our website, pages viewed, information searched for, access times, Websites or applications visited before and after a visitor visits our website, and other relevant statistics. Cookies

Data Governance and trainings

- Sugmya adheres to multiple regulatory and statutory requirements like RBI's Master Direction



for NBFC, Guidelines for NPCI guidelines for Data localization, etc.

- Sugmya conducts periodic internal and external audits of its systems.
- Updates on information security position is updated at regular intervals to Board members, senior management of Sugmya via IT strategy committee as well as Risk Management Committee.
- In all contractual arrangements, we require Sugmya employees, third party agencies/service
 providers to comply with appropriate compliance standards including obligations to protect any
 information and applying appropriate measures for the use and transfer of information. Staff
 also undergo mandatory information security awareness training annually once and at the time
 of joining.
- Any acts involving (i) unauthorized usage/ sharing of Information, (ii) breach of security procedures; (iii) usage of Information for unlawful gain (iv) breach of IT policy/procedure; and (v) breach of confidentiality as per employment terms and/or Code of Conduct, shall warrant appropriate disciplinary action as per Company's Policy.
